1. While on campus, connect your device to the Wi-Fi network "IllinoisNet_Guest"
2. Open a browser window and navigate to [Illinois](#)
3. Your browser will attempt to go to <http://illinois.edu>, but will be redirected to our Wi-Fi Captive Portal page. If you don't see a captive portal page, close your browser app entirely and start from step 2 again.
4. This page will prompt you for your NETID and password to log in. **As a guest or visitor, click the link at the bottom of the page and you can self-register an account.** This account will be valid until 4am the next day.
5. After a brief moment the system should then inform you that you have been given Internet access. Visitors should click "Click Here for Wi-Fi Access" and proceed with having access to the network.
